Cleaning: Vacuum clean frequently, ideally every week. Remove stains as soon as they occur, with clean warm water or sparkling water. Extraction clean when necessary. Extraction cleaning might dissolve water-based glue. Pay attention to temperature and amount of cleaning fluid. Also washable at max. 60-80°C, half wash load. Drip drying. Mount in moist condition. Shrinkage app. 2-3% at 60°C. Be aware of increased shrinking and creasing the higher the temperature
