Composition: 50% polyester, 45% new wool, 5% nylon

Yarn type: Worsted Binding: Plain weave

Width: Approx. 170 cm, 67 inches Weight: Approx. 370 g/lin.m, 11.9 oz/ly

Repeat: None

Colour difference may occur

Cleaning: Vacuum clean frequently, ideally every week.
Remove stains as soon as they occur, with clean warm
water or sparkling water. Extraction clean when necessary.
Extraction cleaning might dissolve water-based glue. Pay
attention to temperature and amount of cleaning fluid.
