Cleaning: Vacuum clean frequently, ideally every week. Remove stains as soon as they occur, with clean warm water or sparkling water. Extraction clean when necessary. Extraction cleaning might dissolve water based glue. Pay attention to temperature and amount of cleaning fluid. Also washable at 30°C, half wash load. Drip drying. Mount in moist condition. No shrinkage when washed at 30°C. Be aware of increased shrinking and creasing the higher the temperature.
