Composition: 42% recycled polyester, 27% viscose, 24% recycled cotton, 7% linen

Yarn type: Chenille

Binding: Jacquard

Width: Approx. 140 cm, 55 inches

Weight: Approx. 1100 g/lin.m, 35.5 oz/ly

Repeat: None

Colour difference may occur

Cleaning: Vacuum clean frequently, ideally every week.

Remove stains as soon as they occur, with clean warm water or sparkling water. Extraction clean when necessary. No ironing only steaming. Steaming might be necessary to remove pressure marks.

Extraction cleaning might dissolve water based glue. Pay attention to temperature and amount of cleaning fluid.
