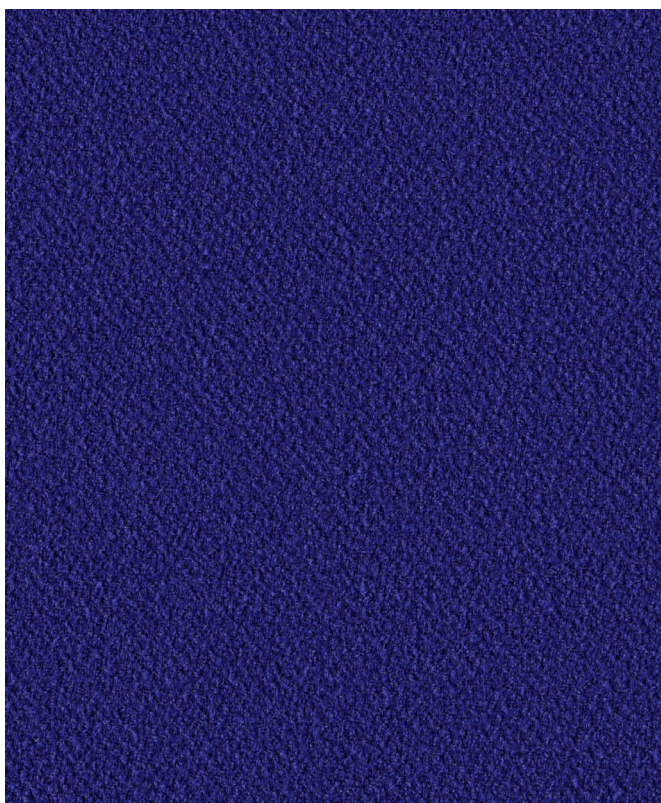

Yarn type: Worsted
Binding: Jacquard
Width: Approx. 140 cm, 54 inches
Weight: Approx. 770 g/lin.m, 25 oz/ly
Repeat: None

Foreign fibres may occur
Colour difference may occur

Cleaning: Vacuum clean frequently, ideally every week.
Remove stains as soon as they occur, with clean warm water or sparkling water. Extraction clean when necessary.
Extraction cleaning might dissolve water-based glue. Pay attention to temperature and amount of cleaning fluid.
